# Law Letter of Recommendation

Dear Sir or Madam:

I would like to recommend and support XXX as an excellent candidate for admission to your esteemed LL.M. program. I am a graduate of New York University's LL.M. program. As a partner at Anderson Mori & Tomotsune and an external counsel, I have worked with Mr. Ikeda for 5 years.
